Call for Abstracts

About the Conference:

To foster collaboration and advance global public health in the Asia-Pacific region, the Asia-Pacific Region Liaison Office (APRLO) of the World Federation of Public Health Associations (WFPHA), along with the Chinese Preventive Medicine Association (CPMA) and the Public Health Association of New Zealand (PHANZ), plans to hold the 2025 Asia Pacific Congress on Public Health (APCPH) in Boao, Hainan, China from November 30 to 30, 2025. The Congress was first established in 2009 with the strong support of WFPHA, and six previous APCPHs have been successfully organized in Beijing, Japan, Bali, Nha Trang, Seoul and Thailand.

The theme of the 2025 Asia-Pacific Conference on Public Health (APCPH) is "Addressing Diverse Challenges, Building a Healthy

Asia-Pacific: Equity, Resilience, Innovation." This theme reflects a critical global priority, as exemplified by the COVID-19 pandemic. Over the past years, this unprecedented public health crisis has exposed systemic vulnerabilities in national and regional health systems worldwide. Strengthening multi-disease prevention and control to safeguard global health security remains a long-term challenge for the international community. As the operating body of the WFPHA Asia-Pacific Regional Liaison Office, the CPMA is committed to enhancing regional public health collaboration. Together with public health organizations across the Asia-Pacific, we will advance the vision of "Building a Global Community of Health for All."

Call for Abstracts:

The 2025 APCPH welcomes the submission of abstracts for original contributions to the relevant field. We encourage work that introduces new ideas, concepts and research and deepens understanding in the field. Please read the following guidelines carefully before submitting your abstract:

Guidelines

Submission: Abstracts can be submitted only online via the "Abstract Submission" column on the 2025 APCPH official website (https://7th-apcph.hnqyhy.com/). Submissions by fax, post or email will not be considered.

Language: As the official language of the conference is English, all abstracts must be in English. If English is not your native language, please arrange for a native English speaker to review your abstract before submission.

Important dates:

31 March 2025: Online abstract submission opens.

30 September 2025, 23:59 Chinese Standard Time: Abstract submission closes. Abstracts will not be accepted after this date.

Selection and awards: Abstracts submitted to the 2025 APCPH will be reviewed by the Conference Academic Committee. The highest-scoring abstracts will be selected for oral presentation (5 minutes) during the conference. Abstracts accepted will be compiled in the 2025 Asia Pacific Congress on Public Health Abstracts. Outstanding abstracts will be recommended for further publication

in relevant international journals as appropriate.

Requirements:

1. <u>Format:</u> Abstract submission requires clear arguments, concise writing and reliable data. The abstract should be in structured format,

written in a four-paragraph format including **Objective**, **Methods**, **Results**, **and Conclusions**. For review paper abstracts, the Objective, Methods, Results, and Conclusion sections may be excluded. 3-8 keywords should be given.

- 2. Word limits: The abstract is limited to 500-800 words.
- 3. <u>Font:</u> Use **Times New Roman** font when formatting the text.
- 4. Abstract submissions should include the First Author's name, affiliation, position and title, contact number and email address.
- 5. A detailed example of the format is attached (Annex).

Attention:

- 1.Papers corresponding to abstracts submitted to the 2025 APCPH should not have been published in other academic conferences or journals.
- 2. Abstracts must not include libelous or defamatory content. Material presented in abstracts must not violate any copyright laws.
- 3. The submission of an abstract constitutes the author(s)' consent for publication. Authors retain the copyright of their abstract, with first publication rights granted to the 2025 APCPH.

Formatting Requirements for Abstract Submissions

Abstracts must include: <u>Title, Author's Name and Information (organization, province and city name and postal code, E-mail address)</u>, <u>Abstract, Keywords, Reporter's profile (including address, Email and contact phone number)</u>, please do not missing items. All submissions must be in <u>English</u>, and the font formatting requirements are as following:

- 1. **Thesis title:** Times New Roman font, size 14, bold; centred; the first letter of the first word is capitalised and the rest of the words are lower case.
- 2. **Author's name:** Times New Roman font, size 10.5; centred; Chinese name in Chinese Pinyin, first name in the front, last name in the back, and the first letter capitalised. For two or more authors, names are separated by ",".
- 3. **Author information:** Times New Roman font, size 10.5; centred; italicised. The name of the organisation, province or city needs to be listed. Corresponding authors are underlined. After the author's information, the contact email address of the paper should be indicated in a new line. The organization should be detailed to the second level (e.g. university: faculty; research institute: department, office).
- 4. **Abstract:** Times New Roman font, size 10.5; 500-800 words. Written in structured abstract format, which is four-paragraph format of Objective, Methods, Results and Conclusions, with "Objective, Methods, Results and Conclusions" in bold; abstracts of the research review papers may exclude the sections on purpose, methods, results, and conclusions.
- 5. **Keywords:** Times New Roman font, size 10.5; 3 to 5 keywords, spaced by semicolons.
- 6. **Author's profile:** Times New Roman font, size 10.5, including Photo, education degree, position and title, main research direction, contact information (E-mail address and telephone number).
- 7. Formatting specifications
- 7.1 Page setup: A4; margins are 2.5 cm left and right, 3 cm top and bottom.
- 7.2 Line spacing: single-spaced; one blank line after the Title, after Author information, and after Keywords.
